GUARANTEE ABORTION RIGHTS IN STATE CONSTITUTION

Amends the California Constitution to enshrine a fundamental right to reproductive freedom. That includes the right to choose to have an abortion and the right to choose or refuse contraceptives.

LEGALIZE SPORTS BETTING AT TRIBAL CASINOS

Allows the state's privately operated racetracks and tribal casinos to offer in-person sports betting. The proposition would also allow additional gambling—such as roulette and dice games, including craps—at tribal casinos.

ALLOW ONLINE SPORTS BETTING

Allows licensed tribes and gaming companies to offer mobile and online sports betting for adults 21 and older outside American Indian tribal lands. The proposition also creates a new division within the state's Justice Department to regulate online sports wagering.

GUARANTEE FUNDING FOR ARTS AND MUSIC EDUCATION

Requires the state to provide additional funding to increase arts and music education in all K-12 public schools (including charter schools). Also allocates a greater proportion of the funds to schools serving economically disadvantaged students.

IMPOSE NEW RULES ON DIALYSIS CLINICS

Requires kidney dialysis clinics to have a physician, nurse practitioner or physician assistant available on site or, in some cases, via telehealth. It also prohibits clinics from closing or reducing services without state approval and from refusing treatment to people based on their insurance type.

TAX MILLIONAIRES FOR ELECTRIC VEHICLE PROGRAMS

Proposes a 1.75% personal income tax increase on Californians making more than \$2 million per year to fund programs that reduce air pollution and prevent wildfires to help achieve State greenhouse gas emission goals. 80% of revenue will be used for buying zero emission vehicles and charging stations.

UPHOLD BAN ON FLAVORED TOBACCO PRODUCTS

Bans most sales of flavored tobacco products and tobacco product flavor enhancers. It also prohibits in-person stores and vending machines from selling most flavored tobacco products or tobacco product flavor enhancers.

UNITED TO HOUSE LA

Enacts a tax on the sale or transfer of properties valued over \$5 million, with qualified affordable housing and government entities exempt from the tax. Establishes the House LA fund to allocate revenue to projects that address housing availability, creates permanently affordable community controlled housing, and creates a citizens' oversight committee.

REMOVAL OF SHERIFF FOR CAUSE

Allows the L.A. County Board of Supervisors to vote to remove the elected sheriff from office for cause, including: violation of laws related to the sheriff's duties; neglect of the sheriff's duties; misuse of public funds or properties; willful falsification of documents; or obstruction of an investigation into the department's conduct.

THE PASADENA FAIR AND EQUITABLE HOUSING CHARTER AMENDMENT

Enacts rent control and eviction protection and creates a rental board and rental registry. A landlord would only be allowed to increase rent annually by 75% of the percentage of last year's inflation (based on Consumer Price Index). Landlords also can only evict tenants for just-cause.
